- 1) The meeting was called to order at 3:15 p.m.
- 2) Introduction of Guests and New Representatives

- 4) Approval of Minutes:
 - a) March 4, 2013
Brent Monte made a motion to approve the minutes, seconded by Mark Blethen; unanimously approved.
- 5) Treasurer's Report (5 minutes) – Ken Woodward
The budget was dispersed. Expenditures were discussed. A discussion ensued on the need to utilize a payroll company.
- 6) Membership Report (5 minutes) – Loma Hopkins
Loma stated that the representatives should have received an email from Deyanira Gonzalez asking for updates to the part-time faculty list for their divisions. Part-time faculty who are a member of a Faculty Association in another district should email Loma to provide information so that they do not pay CCA/NEA dues through our Faculty Association as well (do not pay double dues). They would still need to pay local dues.

9) Need to Hire a Payroll Service – Ken Woodward, Paula Jacobs

a) Request for Official Motion

Deyanera Gonzalez and Ken Woodward interviewed the payroll companies and are suggesting that ADP be utilized. The issue of workman's compensation was discussed as Deyanera will need to be covered. There was a discussion on covering the entire executive committee; however, the cost is too high. Ken suggested that we hire ADP and provide workman's compensation for Deyanera and research others being covered. Lewis Long made a motion to approve hiring ADP for payroll and workman's compensation coverage for Deyanera; seconded by Margot Lovett; unanimously approved.

A motion was made by Kathy Schmeidler to change – “will” to “may” under item 5 and adding a sixth item “exceptions will be reviewed by the Executive Committee, who will make a recommendation to the representative council for approval; seconded by Martin Welc; one abstention; the motion was approved. There was a discussion about delegates that are approved to attend.
